- Diversified strategy with daily liquidity.

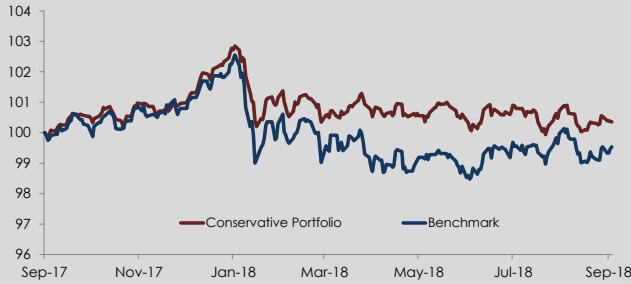

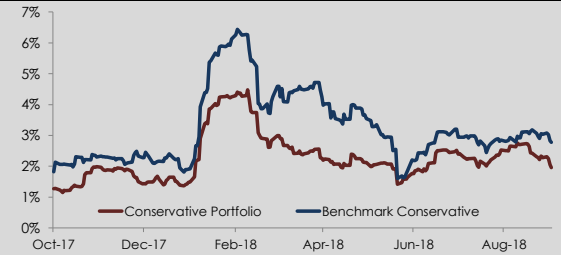

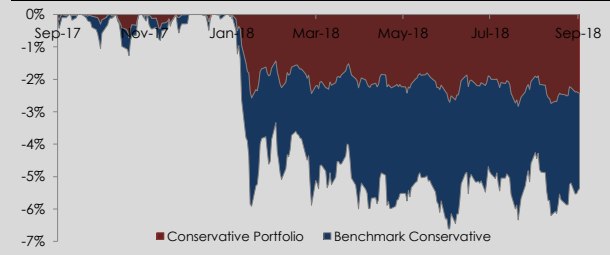

Historical Volatility v/s Benchmark

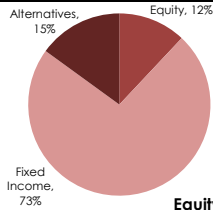


Maximum Drawdown v/s Benchmark

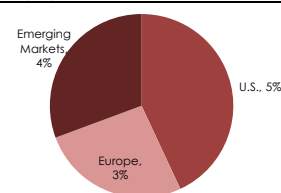

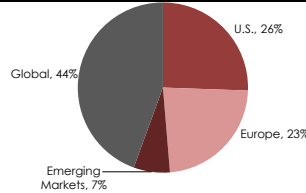
Breakdown by Asset Class



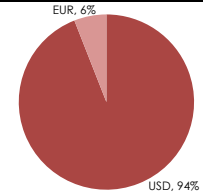
Equity Breakdown (% of total Portfolio)



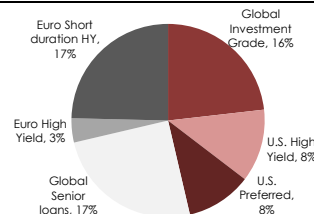
Breakdown by Geography
